This is to inform you that a serious discrepancy has been discovered regarding your 10+2 (class 12<sup>th</sup>) issued by Bihar Sanskrit Board Patna. It has come to our attention that the Class 12th certificate submitted by you is deemed to be fraudulent. The Bihar Sanskrit Board, Patna has verified this certificate as fake. In light of this, you are hereby informed that your registration certificate issued by J&K Medical Council bearing registration no. 18915 dated 17/3/2023 stands cancelled with immediate effect.

You are hereby directed to surrender your original registration certificate as well as submit all other original documents in this office within 7 days from the receipt of this letter. This will facilitate the necessary steps to be taken in order to rectify this situation and address the issue effectively.

Additionally, it is also inform you that due to the seriousness of this matter, we are obliged to initiate legal procedures. A First Information Report (FIR) will be filed with the appropriate law enforcement agency regarding the submission of a fake certificate.

Please be aware that failure to comply with this request may result in further legal consequences. We strongly advise you to take this matter seriously and cooperate fully in order to mitigate any adverse repercussions. =
